Purpose: Establishing cooperation between the Educational Institution and the VIRTUAL YOUTH BUSINESS HUBS INTERNATIONAL NETWORK (VEHUB4YOU) based on joining the network to create and maintain a Virtual Business Hub at the Educational Institution.

#### **Basic Provisions:**

# 1. Joining the Network:

# 2. Creation and Management of the Virtual Business Hub:

- 2.1. The Joining Party agrees to create and manage a Virtual Business Hub within the framework of the VEHUB4YOU network.
- 2.2. The Educational Institution has the right to choose the thematic focus and directions of the Virtual Business Hub's activities and agree with a Project Partner.

## 3. Resource Exchange:

3.1. The Joining Party commits to facilitating the free exchange of educational resources with other participating Educational Institutions in the network under an open license.

## 4. Participation in Common Initiatives:

4.1. The Joining Party expresses readiness to participate in common initiatives and projects conducted within the network.





# 5. License and Financial Obligations:

5.1. Resources provided within the network are used based on an open license without financial obligations between Project Partner and Joining Party.

#### 6. Duration and Termination:

- 6.1. This agreement is valid for the duration of the Joining Party's participation in the VEHUB4YOU network and can be extended by mutual agreement.
- 6.2. Termination of the agreement is possible by mutual consent of the parties.
